Abstract: Changes the name of the "La. Quail Unlimited" prestige license plate to the "La. Quail Forever" license plate.

<u>Present law</u> creates the La. Quail Unlimited prestige license plate for an additional \$26 charge. Provides that the additional \$26 be credited to the quail fund within the Conservation Fund. Authorizes 5% of the revenue from the sale of the La. Quail Unlimited prestige license plate to be used to promote further sales of the license plates.

<u>Proposed law</u> changes the name of the license plate <u>from</u> the "La. Quail Unlimited" plate <u>to</u> the "La. Quail Forever" license plate.
