2	To enact R.S. 38:330.1(C)(2)(d), relative to flood protection authority nominating
3	committee members; to provide relative to term limits for levee district nominating

5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 38:330.1(C)(2)(d) is hereby enacted to read as follows:

Abstract: Establishes term limits for certain flood protection authority nominating committee members.

<u>Present law</u> establishes a nominating committee for the board of commissioners for the Southeast La. Flood Protection Authority-East and the Southeast La. Flood Protection Authority-West.

<u>Proposed law</u> establishes a staggered term of four years for nominating committee members of the Southeast La. Flood Protection Authority-East and Southeast La. Flood Protection Authority-West.

<u>Proposed law</u> provides that no nominating committee member may serve more than two consecutive terms.

<u>Proposed law</u> also provides that service of two or more years constitutes a term.

<u>Proposed law</u> further provides that a nominating committee member may be reappointed four years from the completion of his last term.
