MTR VEHICLE/LICEN PLATES: Provides with respect to special license plates for firefighters with twenty years of service

AN ACT

2	To enact R.S. 47:463(D) and 463.23(D), relative to the special active full-time professional
3	and retired firefighter license plate; to exempt certain firefighters from the annual
4	motor vehicle registration license fee or tax; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 47:463(D) and 463.23(D) are hereby enacted to read as follows:
7	§463. Private passenger vehicles; amputee veterans exempted; church, church
8	school, and religious order vehicles

0	D. Any active, full-time professional or retired firefighter of this state who
1	has served in a professional capacity as a firefighter for twenty or more years and
12	who is issued a special active full-time professional or retired firefighter license plate
13	in accordance with R.S. 463.23 shall be exempt from the annual motor vehicle
4	registration license fee or tax on that particular specialty license plate. Nothing in
15	this Subsection shall be construed to exempt any firefighter obtaining this special
16	prestige license plate from payment of the initial one-time fee at the time the license
17	plate is issued as required by R.S. 463.23(B).

D. Any active, full-time professional or retired firefighter who is issued a

special active full-time professional or retired firefighter license plate pursuant to this

Section, and has served in a professional capacity as a firefighter for twenty or more

years shall be exempt from the annual motor vehicle registration license fee or tax

required by R.S. 47:461 et seq., for that particular specialty license plate. A special

motor vehicle license plate issued to any firefighter pursuant to this Subsection shall

be issued for the lifetime of the firefighter.

Abstract: Exempts firefighters issued a special active full-time professional or retired firefighter license plate from the motor vehicle registration license fee or tax.

<u>Present law</u> provides for an annual motor vehicle registration license fee or tax on all private passenger vehicles.

<u>Present law</u> further provides for the issuance of a special firefighters license plate for active and retired firefighters. <u>Present law</u> requires firefighters issued the plate to pay a one-time fee of \$25 in addition to the annual motor vehicle registration license fee or tax.

<u>Proposed law</u> allows those firefighters issued a special firefighters license plate pursuant to <u>present law</u> and who have served for 20 or more years to be exempt from the annual motor vehicle registration license fee or tax.

<u>Proposed law</u> clarifies that <u>proposed law</u> does not exempt any firefighter receiving a specialty license plate from the initial one-time fee in <u>present law</u>.

<u>Proposed law</u> provides for the issuance of a lifetime specialty firefighters license plate to those firefighters who have served for 20 or more years.
