Abstract: Reduces the number of members of the governing authority of Pointe Coupee Parish who may serve on the board of commissioners of Hospital Service District No. 1 of the parish of Pointe Coupee <u>from</u> three <u>to</u> two.

<u>Present law generally authorizes police juries to form and create one or more hospital service</u> districts within their respective parishes. <u>Present law</u> generally requires that a hospital service district be governed by a board of five commissioners, appointed by the police jury, who are qualified voters and residents of the district. <u>Present law</u> provides that the board for Hospital Service District No. 1 of the parish of Pointe Coupee is comprised of nine members.

### Proposed law retains present law.

<u>Present law</u> provides that three of the members of the governing authority of Pointe Coupee Parish may serve on the board for Hospital Service District No. 1 of the parish of Pointe Coupee. <u>Proposed law</u> reduces that number <u>from</u> three <u>to</u> two.

<u>Proposed law</u> provides that if there are three members of the governing authority of Pointe Coupee Parish serving on the board of the district on the effective date of <u>proposed law</u>, then the term of one of the members terminates on that date, as determined by lot; however, the member must serve until his successor is appointed and takes office.
