LAW ENFORCEMENT: Requires the Louisiana State Police to investigate certain law enforcement officer-involved incidents in East Baton Rouge Parish

AN ACT

2 To enact Chapter 25-A of Title 40 of the Louisiana Revised Statutes of 1950, to be 3 comprised of R.S. 40:2540.1, relative to certain law enforcement officer-involved 4 incidents in East Baton Rouge Parish; to provide relative to the investigation of such 5 incidents; to require the Department of Public Safety and Corrections, public safety services, office of state police, to conduct such investigations; and to provide for 6 7 related matters. 8 Notice of intention to introduce this Act has been published 9 as provided by Article III, Section 13 of the Constitution of 10 Louisiana. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. Chapter 25-A of Title 40 of the Louisiana Revised Statutes of 1950, to be 13 comprised of R.S. 40:2540.1 is hereby enacted to read as follows: CHAPTER 25-A. OFFICER-INVOLVED INCIDENT INVESTIGATIONS IN EAST 14 15 BATON ROUGE PARISH; LOUISIANA STATE POLICE TO CONDUCT 16 §2540.1. Officer-involved incidents in East Baton Rouge Parish; investigation; 17 Louisiana State Police 18 A. The provisions of this Chapter are only applicable to investigations of 19 officer-involved incidents that occur in the parish of East Baton Rouge. B. For purposes of this Chapter: 20

1	(1) "Law enforcement officer" means any Baton Rouge police officer.
2	(2) "Officer-involved incident" means the death of an individual in the parish
3	of East Baton Rouge that results from the discharge of a firearm by a law
4	enforcement officer while the law enforcement officer is on duty or while the law
5	enforcement officer is off duty but performing activities that are within the scope of
6	his law enforcement duties.
7	C.(1) If a law enforcement officer is involved in an officer-involved incident,
8	an official investigation shall be made to determine whether the use of force by any
9	such law enforcement officer was appropriate and necessary. The Department of
10	Public Safety and Corrections, public safety services, office of state police, referred
11	to in this Chapter as the "state police", shall lead all investigative efforts, to include
12	investigative personnel and crime scene personnel.
13	(2)(a) The Baton Rouge police department shall immediately notify the state
14	police of any officer-involved incident. Upon receipt of notification, the state police
15	shall promptly coordinate the dispatch of state police personnel and shall
16	immediately implement an investigation pursuant to state police procedures.
17	(b) The Baton Roue police department shall secure the scene of any officer-
18	involved incident to ensure that physical evidence and documentation is protected
19	and preserved, and that all witnesses are identified and separated pending the arrival
20	of the state police.
21	(3) The state police shall coordinate with the personnel from the East Baton
22	Rouge Parish coroner's office and the office of the district attorney for the 19th
23	Judicial District, referred to in this Chapter as the "district attorney", and any other
24	law enforcement agency required to facilitate the investigation.
25	D.(1) Within twenty-five days of the officer-involved incident, the state
26	police shall provide a briefing to the Baton Rouge police department and the district
27	attorney on the status of the investigation.

1	(2) The state police shall complete the investigation and submit all records
2	of the investigation and a report on the material factual findings to the district
3	attorney within sixty days of the officer-involved incident.
4	(3) If the district attorney determines that there is no basis to prosecute the
5	law enforcement officer involved in the officer-involved incident, the state police
6	shall upon request, make the report public.
7	E.(1) Nothing in this Chapter shall prohibit an internal investigation into the
8	officer-involved incident; however, the internal investigation shall not interfere with
9	the investigation conducted by the state police.
10	(2) All internal or administrative investigations shall be initiated only after
11	the criminal investigation of the officer-involved incident has concluded.
12	F. Compensation for participation by law enforcement investigators may be
13	determined in manner consistent with memorandums of understanding or
14	cooperative endeavor agreements.
15	Section 2. The provisions of this Act shall prevail over any conflicting provisions
16	of the Act which originated as House Bill No of this 2017 Regular Session of the
17	Legislature.
18	Section 3. This Act shall become effective upon signature by the governor or, if not
19	signed by the governor, upon expiration of the time for bills to become law without signature
20	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
21	vetoed by the governor and subsequently approved by the legislature, this Act shall become
22	effective on the day following such approval.

Abstract: Relative to law enforcement officer-involved incidents in East Baton Rouge Parish, requires the La. State Police to investigate such incidents.

Proposed law requires the Dept. of Public Safety and Corrections, public safety services, office of state police (state police) to investigate officer-involved incidents in East Baton

Rouge Parish. Defines "law enforcement officer" as any Baton Rouge police officer and defines "officer-involved incident" as the death of an individual in East Baton Rouge Parish that results from the discharge of a firearm by a law enforcement officer while the law enforcement officer is on duty or while the law enforcement officer is off duty but performing activities that are within the scope of his law enforcement duties.

<u>Proposed law</u> requires the Baton Rouge police department to immediately notify state police of any officer involved incident. Further requires the police department to secure the scene of any officer-involved incident to ensure that physical evidence and documentation is protected and preserved, and that all witnesses are identified and separated pending the arrival of the state police.

<u>Proposed law</u> requires state police to coordinate with the personnel from the East Baton Rouge Parish coroner's office and the office of the district attorney for the 19th Judicial District, and any other law enforcement agency required to facilitate the investigation.

<u>Proposed law</u> requires state police to provide a briefing on the investigation to the Baton Rouge police department within 25 days of the officer-involved incident, and to submit all records of the investigation and a report on the material factual findings to the district attorney within 60 days.

<u>Proposed law</u> provides that nothing in <u>proposed law</u> prohibits an internal investigation into the officer-involved incident, but the internal investigation cannot interfere with the investigation conducted by the state police.

Effective upon signature of governor or lapse of time for gubernatorial action.
