COMMENDATIONS: Commends Augustus Brown Sr., posthumously upon his extraordinary life and numerous accomplishments

1	A CONCURRENT RESOLUTION
2	To commend Augustus Brown Sr., posthumously for his extraordinary life and numerous
3	accomplishments.
4	WHEREAS, it is appropriate that Augustus G. Brown Sr., be commended and
5	honored for his extraordinary life and significant contributions as a Tuskegee airman and
6	World War II veteran; and
7	WHEREAS, the Tuskegee Airmen were the first African American servicemen to
8	serve as military aviators in the United States armed forces, flying with distinction during
9	World War II; and
10	WHEREAS, breaking racial barriers, the Tuskegee Airmen overcame segregation
11	and prejudice to become one of the most highly respected fighter groups of World War II
12	for protecting bombers on missions over Nazi Germany; and
13	WHEREAS, the revolutionary successes of the Tuskegee Airmen helped pave the
14	way for the eventual integration of the United States armed forces; and
15	WHEREAS, Terrebonne Parish native, Augustus G. Brown Sr., partook in the
16	legendary accomplishments of the Tuskegee Airmen during World War II; and
17	WHEREAS, during his senior year at Leland College, Mr. Brown bravely enlisted
18	in the military in the midst of World War II; and
19	WHEREAS, after completing basic training and officer-training school, Mr. Brown
20	was selected to join the elite all-black fighter squadron, having originally been assigned to
21	the 101 st Squadron, which later became a part of the 332 nd Fighter Group; and

1 WHEREAS, he later joined the 99th Fighter Squadron, which was popularly known 2 as "Redtails" because of the crimson paint on the tails of their P-51 Mustangs; and 3 WHEREAS, after serving his country, Mr. Brown returned to college, earning his 4 bachelor's degree in science in 1947 from Leland College; he subsequently earned his 5 master's degree in administration from Southern University and A&M College; and 6 WHEREAS, Mr. Brown became the only African American member of the 7 Terrebonne Flying Posse and the Experimental Aircraft Association; later in life, he also 8 became a member of the Houma Airport Commission; and 9 WHEREAS, in addition to his remarkable military career, Mr. Brown had a 10 distinguished career in education, having taught at the Houma Colored School, C.M. 11 Washington High School, and South Terrebonne High School; he also served as vice 12 principal of South Terrebonne High School and principal of the Schriever Colored School 13 and Ellender Junior High School; and 14 WHEREAS, in 1978, Mr. Brown was promoted to the position of child-welfare and 15 attendance supervisor, where he served until his retirement in 1983; and 16 WHEREAS, Mr. Brown passed away in 1999 at the age of seventy-eight; and 17 WHEREAS, Augustus G. Brown Sr., dedicated his life to the service of his family, 18 community, and nation as a husband, father, soldier, and a beloved and respected individual 19 who is so richly deserving of this long-overdue recognition. 20 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 21 commend posthumously Augustus G. Brown Sr.; does hereby recognize and record for 22 posterity the tremendous valor and fortitude he displayed as a Tuskegee airman; and does 23 hereby express the enduring appreciation of his fellow citizens for the great sacrifices he 24 made in the name of freedom. 25 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted

to the family of Augustus G. Brown Sr.
