HOUSE CONCURRENT RESOLUTION NO. 30

CORRECTIONS: Directs the secretary of the Dept. of Public Safety and Corrections to determine the feasibility and potential savings of privatizing correctional facilities and using the savings for programs for state offenders housed at local facilities

1	A CONCURRENT RESOLUTION
2	To direct the secretary of the Department of Public Safety and Corrections to determine the
3	feasibility and potential savings of privatizing certain correctional facilities and using
4	the savings to fund programs for state offenders housed at local facilities.
5	WHEREAS, the Louisiana Corrections Private Management Act, R.S. 39:1800.1
6	through 1800.7, includes legislative findings that "adequate and modern prison facilities are
7	essential to the safety and welfare of the people of this state, and that contracting for portions
8	of governmental services is a viable alternative considering the fiscal problems facing the
9	state"; and
10	WHEREAS, the Louisiana Corrections Private Management Act is limited to state
11	institutions opened after June 28, 1989, and not operational as of May 22, 1989, but other
12	provisions of state law, including provisions regarding the leasing of state property and
13	multiyear contracts, authorize contracts for similar purposes and for similar durations as the
14	Louisiana Corrections Private Management Act; and
15	WHEREAS, if funding were available to provide additional services for state
16	offenders housed at local facilities, these services could reduce recidivism of such offenders,
17	thereby reducing future costs.
18	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
19	direct the secretary of the Department of Public Safety and Corrections to report to the
20	legislature by December 31, 2017, a determination of the feasibility of privatizing other state

- 1 correctional facilities, excluding Louisiana State Penitentiary and Elayn Hunt Correctional
- 2 Center, and the potential cost savings from privatizing the facilities, and recommendations
- 3 for programs for state offenders housed locally to be funded with the potential savings.
- 4 BE IT FURTHER RESOLVED that the secretary shall review current laws regarding
- 5 public contracts and leases to determine if privatizing other facilities is possible under
- 6 current state law, and if not, to provide recommendations to the legislature for legislation no
- 7 later than December 31, 2017.
- 8 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
- 9 to the secretary of the Department of Public Safety and Corrections.

Requires determinations to be submitted to the legislature by Dec. 31, 2017.
