<u>Proposed law</u> designates the parallel bridges crossing the Reserve Relief Canal on Interstate 10 in St. John the Baptist Parish as the "Spencer Chauvin Memorial Bridge".

<u>Proposed law</u> designates US 190 in West Baton Rouge Parish from the foot of the Mississippi River Bridge to its intersection with LA 415 as the "Trooper Francis C. Zinna Memorial Highway", notwithstanding any other law to the contrary.

<u>Proposed law</u> designates US 190 within the corporate limits of the town of Livonia, in Pointe Coupee Parish as the "Lawrence Russo Memorial Highway", notwithstanding any other law to the contrary.
