2	To amend and reenact R.S. 56:722(A)(2) and 727, relative to game and fish commissions;
3	to provide for the adoption of rules and regulations; to provide for limitation of
4	liability; to provide for terms and conditions; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 56:722(A)(2) and 727 are hereby amended and reenacted to read as
7	follows:
8	§722. Game and fish commission; rules and regulations
9	A.(1) * * * *
10	(2) The commission may make rules and regulations for the government,
11	regulation, and control of the preserve and for the conservation, protection, and
12	propagation of game and fish in the preserve, provided that such rules and
13	regulations shall be finally approved, adopted, and promulgated by the Louisiana
14	Wildlife and Fisheries Commission, in accordance with R.S. 56:727.

2	(1) After being approved by the Louisiana Wildlife and Fisheries

6	(2) If the Louisiana Wildlife and Fisheries Commission fails to take

<u>Present law</u> requires that if a game and fish commission makes rules and regulations for the government, regulation, and control of the preserve and for the conservation, protection, and propagation of game and fish in the preserve, such rules and regulations shall be finally approved, adopted, and promulgated by the La. Wildlife and Fisheries Commission.

<u>Proposed law</u> provides that if the La. Wildlife and Fisheries Commission fails to take action on the proposed rules and regulations within 180 days after submission by the commission, then the proposed rules and regulations shall be deemed to be adopted.

<u>Proposed law</u> limits the liability of the La. Wildlife and Fisheries Commission if the proposed rules and regulations are deemed to be adopted by failure of the commission to act within 180 days after submission by the game and fish commission.

Effective August 1, 2017.
