HOUSE RESOLUTION NO. 65

COMMENDATIONS: Commemorates the eightieth anniversary of the American System of Conservation Funding

A RESOLUTION

2 To commemorate the eightieth anniversary of the American System of Conservation 3 Funding. 4 WHEREAS, more than a century ago, sportsmen and women were among the first 5 conservationists who realized America's natural resources were in peril and could not sustain 6 unregulated harvest and habitat destruction; and 7 WHEREAS, sportsmen and women took it upon themselves to support laws that 8 stopped excessive harvest of fish and wildlife, established game and fish agencies to protect 9 fish and wildlife and their habitat, and supported fishing and hunting license fees to help 10 fund the new agencies' efforts to provide for healthy natural resources for future generations; 11 and 12 WHEREAS, upon realizing that license fees alone were insufficient to restore and 13 sustain healthy fish and wildlife populations, sportsmen and women supported excise taxes 14 on firearms, ammunition, archery equipment, hunting equipment, and fishing equipment to 15 raise additional funds to support restoration and enhancement efforts of the state agencies; 16 and 17 WHEREAS, this "user-pays, public-benefits" system became known as the Wildlife 18 and Sport Fish Restoration Program, and it began eighty years ago with the passage of the 19 Federal Aid in Wildlife Restoration Act in 1937 and then was bolstered with the passage of 20 the Federal Aid in Sport Fish Restoration Act in 1950 and the Wallop-Breaux amendment 21 to the Sport Fish Restoration Act in 1984; and

1	WHEREAS, the Wildlife and Sport Fish Restoration Program also permanently
2	linked revenue from hunting and angling licenses to conservation, creating the American
3	System of Conservation Funding as it exists today; and
4	WHEREAS, the combined contribution of the American System of Conservation
5	Funding to state fish and wildlife agencies exceeds \$57 billion, more than any other single
6	conservation effort in American history; and
7	WHEREAS, the manufacturers of firearms, ammunition, and hunting, fishing, and
8	boating equipment have collected excise taxes on firearms, ammunition, archery equipment,
9	manufactured fishing tackle, electric trolling motors, marine electronics, and motorboat fuel
10	and distributed these funds to the states through the U.S. Fish and Wildlife Service; and
11	WHEREAS, this cooperative partnership between industry, hunters, anglers, trappers,
12	boaters, recreational shooters, the U.S. Fish and Wildlife Service, and state natural resource
13	agencies has resulted in the most successful model of fish and wildlife management in the
14	world, restoring populations from coast to coast and in Alaska and Hawaii.
15	THEREFORE, BE IT RESOLVED that the House of Representatives of the
16	Legislature of Louisiana does hereby commemorate the eightieth anniversary of the
17	American System of Conservation Funding and does hereby commend America's hunters,
18	anglers, trappers, boaters, recreational shooters, state fish and wildlife agencies, and the U.S.
19	Fish and Wildlife Service for their leading role in restoring healthy populations of fish and
20	wildlife and other natural resources, both game and nongame, to the abundance we see
21	today.
22	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
23	to the secretary of the Louisiana Department of Wildlife and Fisheries and to each member
24	of the Louisiana congressional delegation.
