3	observance of Charles W. Ross Day on April 29, 2017, in the city of Opelousas.
4	WHEREAS, Charles W. Ross was born to Beatrice Mantell, a single mother, and was
5	raised in Opelousas; and
6	WHEREAS, Mr. Ross married his high school sweetheart, Wilda Alsandor, on
7	April 7, 1955, and he has been blessed with four sons, eight grandchildren, and one
8	great-grandchild; and
9	WHEREAS, Charles Ross answered the call of duty to his country and served in the
10	United States Army from 1953-1955 and was discharged honorably; and
11	WHEREAS, he received a bachelor's degree in secondary education and a master's
12	degree in education with a specialization in guidance from Southern University; from there,
13	Mr. Ross launched a long and distinguished career in education: from 1959-1971, Charles
14	Ross taught history at Washington Elementary School and Dunbar High School; from
15	1970-1972, he served on the board of Holy Ghost High School; from 1971-1984, he was a
16	counselor at Washington High School; from 1974-1976, Mr. Ross served on the board at
17	Opelousas Catholic High School; from 1978-1984, he was a counselor at the St. Landry
18	Parish Group Home for boys; and from 1985-1991, he was the principal of East Junior High

2	Opelousas City Department heads from 1991-1994; he also served as a member of the
3	St. Landry Parish Head Start board of directors; and
4	WHEREAS, Charles Ross is a board member of CASA of St. Landry-Evangeline,
5	Inc. and the St. Landry Federal Credit Union and a member of the St. Landry Parish school
6	board; and
7	WHEREAS, Charles W. Ross has been a member of St. Mark United Methodist
8	Church since 1934 and is a lay leader and a member of the Male Group and the choir; and
9	WHEREAS, in honor of his many contributions to Opelousas and St. Landry Parish,
10	Mayor Reginald Tatum and the Board of Alderman of Opelousas have proclaimed April 29,
11	2017, as Charles W. Ross Day in the city, and it is fitting to salute this fine son of Louisiana
12	upon the observance of his special day.
