Establishes a permit fee for milk and dairy farms and plants

Proposed law requires the La. Dept. of Health to charge the following annual permit fees:

- (1) Dairy farms \$90 per permit
- (2) Dairy plants \$300 per permit
- (3) Single service milk and milk product container or closure manufacturing plants \$300 per permit

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

The proposed law requires La. Dept. of Health to charge annual permit fees for dairy farms (\$90), dairy plants (\$300), and single service milk and milk product container or closure manufacturing plants (\$300). In current practice, the department charges these specific fees in the same amount required by the bill. The proposed law codifies existing practices into law. Therefore, there are no anticipated additional revenue collections as a result of this measure.
