5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 3:903 and 904(B) are hereby amended and reenacted to read as
7	follows:
8	§903. Fees for inspection, classification, and grading
9	The commission commissioner may collect fees for the inspection,
10	classification, and grading of farm products, fruits, and vegetables. The fees shall
11	not exceed the actual cost necessary to provide for the proper inspection, grading,
12	and classification of the products.
13	§904. Penalty for violations; injunctive relief; costs
14	* * *
15	B. In addition to the penalties authorized in this Section, the commission
16	commissioner may apply for injunctive relief restraining violations of this Part or
17	institute necessary actions for failure to pay accounts due the commission

Abstract: Clarifies the authority of the commissioner regarding the mislabeling of fresh fruits and vegetables.

<u>Present law</u> authorizes the commission to collect fees for the inspection, classification, and grading of farm products, fruits, and vegetables.

<u>Present law</u> authorizes the commission may apply for injunctive relief restraining violations of this Part or institute necessary action for failure to pay accounts due.

Proposed law changes reference to commission in present law to commissioner.

<u>Present law</u> specifies that injunctive relief restraining violations of the Part or necessary actions instituted may be taken for failure to pay accounts due to the commission.

<u>Present law</u> provides that the person condemned in any such proceeding shall be liable for the costs of court and for any additional costs incurred by the commission in gathering the necessary evidence, including reasonable attorney and expert witness fees.

<u>Proposed law</u> changes reference to commission in <u>present law</u> to department.
