Provides legal services (opinions, counsel, and representation) in the areas of public finance and contract law, 13 14 education law, land and natural resource law, collection law, consumer 15 protection/environmental law, auto fraud law, and insurance receivership law. Conducts or assists in criminal prosecutions; acts as advisor for district attorneys, legislature and law 16 enforcement entities; provides legal services in the areas of extradition, appeals and habeas 17 18 corpus proceedings; prepares attorney general opinions concerning criminal law; operates 19 White Collar Crimes Section, Violent Crime and Drug Unit, and Insurance Fraud Unit; 20 investigates and prosecutes individuals and entities defrauding the Medicaid Program or 21 abusing residents in health care facilities and initiates recovery of identified overpayments; 22 and provides investigation services for the department. Serves as legal advisor to gaming 23 regulatory agencies (Louisiana Gaming Control Board, Office of State Police, Department 24 of Revenue and Taxation, Louisiana State Racing Commission, and Louisiana Lottery 25 Corporation) and represents them in legal proceedings."
