<u>Present law</u> allows courts to award damages to persons requesting public records that have been capriciously and arbitrarily withheld by the custodian of the record. <u>Proposed law</u> further allows courts to issue civil penalties of up to \$100 for withholding records in a manner deemed arbitrary and capricious, exclusive of Saturdays, Sundays, and public legal holidays.

## **EXPENDITURE EXPLANATION**

<u>Proposed law</u> will increase expenditures for state agencies and local governmental entities <u>only to the extent they are the</u> <u>custodian of a public record and a court determines that they have capriciously and arbitrarily withheld the record in</u> <u>question</u>. <u>Present law</u> already provides that persons requesting a record that has been capriciously and arbitrarily withheld may be awarded damages by the court upon actual damages being proven by the requester of the record. <u>Proposed law</u> represents an expansion of penalties for the arbitrary and capricious withholding of public records, further allowing courts to award the requester civil penalties not to exceed \$100 per day, exclusive of Saturdays, Sundays, and legal public holidays.

The expenditure increase for state agencies and local governmental entities associated with <u>proposed law</u> is indeterminable and based on two primary factors. State agencies and local governmental entities must first withhold a public record, then a court must determine if the withholding is arbitrary or capricious before awarding the new civil penalty. Presently such occasions are not tracked by the LA Supreme Court. However, because the penalty is \$100 per day, expenditure increases associated with the award and payment of civil penalties are presumed to be low, though ultimately indeterminable.

<u>Note:</u> because state agencies are funded using various means of finance, civil penalties may be paid using a number of different sources dependent upon an agency's appropriated budget authority.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
