The monthly reports required by the provisions of R.S. 39:320.2(C) for all state agencies with escrow funds in the state treasury shall be submitted to the review board, who shall compile the agency reports into one report and forward it to the Joint Legislative Committee on the Budget.

<u>H.</u> The legislative auditor shall review each state agency's compliance with
 the review board's approved cash management policies and procedures. Any
 noncompliance shall be reported to the Legislative Audit Advisory Council and to
 the cash management review board."
