	(3) Goods and services may be sold to the governing authorities of parishes,
	municipalities, other political subdivisions, and public employees.
	(3)(4) Services shall be provided at a cost that is not less than the cost to the
	department for providing the services. Manufactured products shall be provided at
	a cost that is not less than the cost of the raw materials used to manufacture the
	product. If the manufactured product is deemed to be spoiled, overstocked, obsolete
	or otherwise not salable at a cost equal to or greater than the raw material cost of the
	manufactured product and can be documented as such, the director may authorize a
