11 On page 2, delete lines 18 through 20 and insert the following:

12 "(2)(a) Subject to the provisions of Subparagraph (b) of this Paragraph, the
13 council shall provide for services to be provided at each center designated in
14 Subsection A of this Section as requested by the director of the center.

15 (b) The council shall provide for and fund all services requested by the
16 director of a center until the value of the services provided for and funded pursuant
17 to this Paragraph at the center reaches ten thousand dollars in a fiscal year. However,
18 the council may fund additional services requested by a center director pursuant to
19 Subparagraph (a) of this Paragraph subject to the approval of the governing body of
20 the council.

21 (3) The services provided pursuant to this Section shall be for residents age
22 sixty or over exclusively, and may include."
