Expands requirements within driver education and prelicensing training courses

Proposed law directs the Dept. of Public Safety, Office of Motor Vehicles (OMV) to establish portions of the "driver's education course" and "prelicensing training course" relative to littering and management of a routine traffic stop. Proposed law includes minimum instruction requirements for the management of a routine traffic stop. Proposed law requires OMV to promulgate rules to implement provisions of proposed law.
