<u>Proposed law</u> directs the Dept. of Public Safety, Office of Motor Vehicles (OMV) to establish portions of the "driver's education course" and "prelicensing training course" relative to littering and management of a routine traffic stop. <u>Proposed law</u> includes minimum instruction requirements for the management of a routine traffic stop. <u>Proposed law</u> requires OMV to promulgate rules to implement provisions of <u>proposed law</u>.
