12 **(b) Non-discretionary expenditures including the costs to provide such**  
13 **expenditures in the ensuing fiscal year.**

14 **(c) The mandatory statewide adjustments provided for in R.S. 39:29 for**  
15 **the ensuing fiscal year.**

16 **(d) Discretionary expenditures at the existing operating budget level as**  
17 **of December first for the current fiscal year without growth.**

18 **(e) Adjustments for the elimination of non-recurring expenditures.**

19 **In the event mid-year reductions occur after December first, an addendum to**  
20 **the non-discretionary adjusted standstill budget shall be submitted with the**  
21 **governor's executive budget. The non-**

32 **operating budget as of December first, including the cost to provide the**  
33 **mandatory expenditures in the ensuing fiscal year, and the growth in the**  
34 **mandatory statewide adjustments.**

35 **(3) The third column shall be the continuation budget as provided for**  
36 **in this Section.**

1                   **(4) The fourth column shall represent the difference between the non-**  
2                   **discretionary adjusted standstill budget and the continuation budget.**
