Amendments proposed by House Committee on Ways and Means to Original House Bill No. 145 by Representative Garofalo

1 AMENDMENT NO. 1

2 On page 1, line 5, after "technician," and before the semi-colon ";" delete "or paramedic" and
3 insert "paramedic, or volunteer firefighter"

4 AMENDMENT NO. 2

5 On page 1, delete lines 17 through 19 in their entirety and on page 2, delete lines 1 through
6 14 in their entirety and insert the following:

7 ~~(M)(1) For ad valorem taxes due in 2017 and thereafter, an~~ There is hereby
8 established an exemption from ad valorem tax for the total assessed value of the
9 homestead of the unmarried surviving spouse of a person who died ~~while on active~~
10 duty as a ~~under the conditions enumerated in Subsubparagraphs (1)(a) or (b) of this~~
11 Paragraph, and if the conditions established in Subsubparagraph (1)(c) of this
12 Paragraph are met.

13 (1)(a) For ad valorem taxes due in 2017 and thereafter, the exemption shall
14 apply beginning in the tax year in which any of the following persons died or 2017,
15 whichever is later:

16 (i) A member of the armed forces of the United States or the Louisiana
17 National Guard ~~who died while on active duty, or while performing their duties as~~
18 a

19 (ii) A state police officer, ~~or a~~ who died while on duty.

20 (iii) A law enforcement or fire protection officer who qualified for the salary
21 supplement authorized in Section 10(D)(3) of this Article ~~is entitled to an exemption~~
22 from ad valorem tax for the total assessed value of their homestead. ~~The exemption~~
23 shall apply beginning in the tax year in which the person died or 2017, whichever is
24 later, and shall be applicable only if all of the following conditions are met: ~~who died~~
25 while on duty.

26 (b) For ad valorem taxes due in 2018 and thereafter, the exemption shall
27 apply beginning in the tax year in which any of the following persons died or 2018,
28 whichever is later:

29 (i) An emergency medical responder, technician, or paramedic, as such terms
30 may be defined by law, who died while performing the duties of their employment.

31 (ii) A volunteer firefighter, verified by the Office of the State Fire Marshal
32 to have died while performing firefighting duties."

33 AMENDMENT NO. 3

34 On page 2, line 16, after "residence of the" delete the remainder of the line, delete lines 17
35 through 19 in their entirety, and insert the following:

36 "person enumerated in Subsubparagraphs (a) or (b) of this Subparagraph at the time
37 of their death."
