TAX/SALES-USE, ST-EXEMPT: Provides for the state sales and use tax exclusion for pollution control machinery and equipment

1	(bbb) Machinery and equipment necessary to control pollution at a plant
2	facility where pollution is produced by the manufacturing operation, including
3	machinery and equipment used in the production, processing, and storing of food and
4	fiber or of timber manufacturers assigned a North American Industrial Classification
5	System code within Sector 11 when that machinery and equipment is required to
6	comply with emission standards provided by rule by the United States
7	Environmental Protection Agency.

9	Section 2. This Act shall become effective on July 1, 2017; if vetoed by the governor
10	and subsequently approved by the legislature, this Act shall become effective on July 1,
11	2017, or on the day following such approval by the legislature, whichever is later.

Abstract: Provides for the state sales and use tax exclusion for pollution control equipment required for manufacturing machinery and equipment.

<u>Present law</u> provides a state sales and use tax exclusion for certain manufacturing machinery and equipment, including necessary pollution control equipment.

<u>Proposed law</u> includes machinery and equipment used by the agriculture and timber industries that is required by the U.S. Environmental Protection Agency.

Effective July 1, 2017.
