1 A CONCURRENT RESOLUTION

2 To designate Wednesday, May 17, 2017, as Louisiana Housing Council Day at the state  
3 capitol and to commend the Louisiana Housing Council for its accomplishments.

4 WHEREAS, the Louisiana Housing Council (LHC) is composed of more than two  
5 hundred public housing entities which are subdivided across six regions in the state; and

6 WHEREAS, the LHC promotes and advances the availability of affordable housing  
7 to approximately seventeen thousand low-income residents, of which more than one-fourth  
8 are elderly and handicapped; and

9 WHEREAS, many of its member agencies provide a number of services related to  
10 housing issues, which include job training, home ownership assistance, protective services,  
11 child care, educational assistance, and youth services; and

12 WHEREAS, the LHC strives to create stronger, more dynamic communities and  
13 works with other local agencies to enhance the quality of life for citizens throughout the  
14 state; and

15 WHEREAS, the LHC awards scholarships to high school students based on academic  
16 achievement, extracurricular activities, family need, and community involvement; and

17 WHEREAS, the organization honors the achievements of its outstanding members,  
18 those who promote excellence in housing administration with exemplary leadership, high  
19 ethical standards, and exceptional management skills, with the presentation of the Philip W.  
20 Miller award; and

1           WHEREAS, the council strives to provide decent, safe, and sanitary housing and to  
2 reduce crime, poor health, and blighted property, thereby benefitting society as a whole; and

3           WHEREAS, the LHC will hold its annual legislative conference in Baton Rouge May  
4 16-19, 2017.

5           THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
6 designate Wednesday, May 17, 2017, as Louisiana Housing Council Day at the state capitol  
7 and does hereby commend the Louisiana Housing Council for its outstanding  
8 accomplishments.

9           BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted  
10 to Tanya Mabry, president of the Louisiana Housing Council.
