6 after securing a sixty-nine to forty-nine victory over the University Laboratory High School  
7 Lady Cubs; and

9 championship for the Lady Eagles and erases the bitter taste of a state runner-up finish in the  
10 2016 state championship game; and

2 a first-team selection to the 2017 All-District 6-3A girls' basketball team, as well as being  
3 selected Most Valuable Player for the 2017 All-District 6-3A girls' basketball team; and

4 WHEREAS, the accolades did not stop there as Leah Collins and Megan Hatch  
5 received honorable mention selections to the 2017 Class 3A All-State girls' basketball team  
6 and Megan Hatch was also named to the 2017 All-District 6-3A girls' basketball team, with  
7 coach Christina Lockett Anderson being selected Coach of the Year; and

8 WHEREAS, it is appropriate to commend the Parkview Baptist High School girls'  
9 basketball team upon winning the 2017 Division II State Championship; and

10 WHEREAS, all alumni and fans recognize the tremendous honor, pride, and joy that
