"the entity through which final adjudicatory hearings on disciplinary matters are conducted shall be, at the discretion of the licensee facing charges, either the board having jurisdiction over the licensee's profession or the division of administrative law.

(2) Hearings conducted by a board shall be conducted in accordance with the procedures in Title 37 ascribed to that particular board.

(3) Hearings conducted by the division of administrative law"
