5 On page 1, line 13, after "Section 1." and before "and 287.67" delete "R.S. 47:242(1)(g) and  
6 (h) and (2)" and insert "R.S. 47:242"

7 AMENDMENT NO. 3

8 On page 3, line 18, after "or" and before "work" delete "emergency related" and insert  
9 "emergency-related"

10 AMENDMENT NO. 4

11 On page 3, at the end of line 27, delete "emergency related" and insert "emergency-related"

12 AMENDMENT NO. 5

13 On page 4, at the end of line 14, delete the comma "," and delete lines 15 and 16 in their  
14 entirety and insert the following:

15 "to implement the provisions of this Section including, but not limited to rules to  
16 develop and issue forms or establish online processes."

17 AMENDMENT NO. 6

18 On page 5, delete line 3 in its entirety and insert the following:

19 (a) ~~rents~~ Rents and royalties from immovable or corporeal movable  
20 property;

21 (b) ~~profits~~ Profits from sales or exchanges of property (including ~~such~~ items  
22 such as stocks, bonds, notes, land, machinery, mineral rights) not made in the regular  
23 course of business;

24 (c) ~~interest~~ Interest income;

25 (d) ~~dividends~~ Dividends from corporate stock;

26 (e) ~~royalties~~ Royalties or similar revenue from the use of patents, trade  
27 marks, copyrights, secret processes, and other similar intangible rights;

28 (f) ~~income~~ Income from estates, trusts, and partnerships."

3 wages,"

4 AMENDMENT NO. 8

5 On page 5, line 5, after "services" and before "salaries" delete the semicolon ";" and delete  
6 "however," and insert a period "." and insert "However,"

7 AMENDMENT NO. 9

8 On page 5, at the end of line 8, delete the semicolon ";" and insert a period "."

9 AMENDMENT NO. 10

10 On page 5, at the beginning of line 9, after "(h)" delete the remainder of the line and insert  
11 the following:

12 "~~income~~ Income from construction, repair, or other similar services. However,"

14 On page 5, at the end of line 13, delete the period "." and insert the period "."
