5 offender law; to provide relative to the amount of time that must elapse  
6 between the current and prior offense for the habitual offender law to apply;  
7 to provide for the"

9 On page 1, line 5, after "under the" and before "under certain" change "Habitual Offender  
10 Law" to "habitual offender law"

11 AMENDMENT NO. 3

12 On page 1, line 6, after "circumstances;" and before "and" insert "to define "correctional  
13 supervision";"

14 AMENDMENT NO. 4

15 On page 2, line 7, after "then" and before the colon ":" insert "**the following sentences**  
16 **apply**"

18 On page 2, line 10, after "conviction" delete the remainder of the line, delete line 11 in its  
19 entirety, and insert a period "."

31 subsequent felony for a determinate term not less than the longest prescribed  
32 for a first conviction but in no event less than twenty years and not more than
