The proposed law establishes the Work Out Now: WON Louisiana Legislative Commission, comprised of 12 legislative members, to work directly with local officials to bring the battle against obesity to the local level. The Commission shall meet only during legislative session at the state capitol. Upon request by the chairman, the staff of the Senate Committee on Health & Welfare shall support and assist the commission; and may submit a written request to the President of the Senate, Speaker of the House of Representatives, Legislative Fiscal Officer, Legislative Auditor, or Commissioner of Administration for specific support and assistance to be provided by the staffs of their respective agencies. Each agency and political subdivision shall furnish aid, services, and assistance as requested by the Commission. Unless reauthorized by the Legislature, the proposed law shall expire on 7/1/2020.

EXPENDITURE EXPLANATION

The proposed legislation will result in an indeterminable increase in expenditures of the Commission. Costs may be incurred to the extent that staff from various agencies are required to travel to meetings at the state capitol. The LLA has indicated that if the workload is not of a minimal nature, the cost will be \$10,500 for every 100 hours committed to the Work Out Now: WON Louisiana Legislative Commission. The LFO and staffs of the House of Representatives, Senate, Division of Administration, agencies, and political subdivisions will likely absorb any additional duties with existing staff and resources.
