24 "be exempt from prosecution under this Section for the possession, production, 25 or manufacture of marijuana or any of its derivatives at the production facility 26 designated by the Department of Agriculture and Forestry or for the 27 transportation of marijuana or any of its derivatives in accordance with 28 Department of Agriculture and Forestry rules and regulations. This Paragraph 29 shall not prevent the arrest or prosecution of any person for diversion of 30 marijuana or any of its derivatives from the production facility designated by 31 the Department of Agriculture and Forestry or other conduct outside the"

33 On page 3, between lines 23 and 24, insert the following:

34	"(6)(a) The defenses in Paragraph (1) of this Subsection shall be raised by
35	reproducing a patient's medical records that have been created by his attending
36	physician, that contain the recommendation to possess marijuana for
37	therapeutic use in a form permissible under R.S. 40:1046.

38	(b) Notwithstanding any other provision of law to the contrary, except when the
39	person to be arrested has committed a felony, although not in the presence of
40	the officer, no peace officer may arrest any employee, board member, director,
41	or agent during the course and scope of his employment with the following,
42	pursuant to R.S. 40:1046:
43	(i) A pharmacy licensed to dispense marijuana for therapeutic use.

- A pharmacy licensed to dispense marijuana for therapeutic use. <u>(i)</u>
 - (ii) A licensee of marijuana for therapeutic use or its subordinate licensed contractor.
- 46 (iii) A testing laboratory of marijuana for therapeutic use, authorized to do 47 business.

1(iv)A licensed researcher of marijuana for therapeutic use, performing his2official duties.

3(c) The defendant shall bear the burden of proving that the possession,4manufacture, production, transportation, or distribution was in accordance5with the state-sponsored medical marijuana program, the Louisiana Board of6Pharmacy rules and regulations, or the Department of Agriculture and Forestry7rules and regulation, as applicable."
