Signs shall comply with the current manual and specifications adopted by the Department of Transportation and Development pursuant to R.S. 32:235.

## **EXPENDITURE EXPLANATION**

There may be an increase in local government expenditures of municipalities or parishes that would need to purchase signs as a result of this measure.

According to information from the Louisiana Municipal Association and the Police Jury Association, there are less than 10 communities in the state that have speed cameras and the cost for each new sign would be approximately \$40-\$50.

According to officials with the City of New Orleans, they already have signs posted for their mobile speed cameras and there would be no cost to bring them into compliance with the provisions of this measure.

According to officials with the Lafayette Consolidated Government, the cost would be minimal to post signs for their mobile speed cameras.

According to officials with the City of Gretna, the cost would be approximately \$2,000 to purchase signs for their mobile speed cameras.

## **REVENUE EXPLANATION**

## There is no anticipated direct material effect on governmental revenues as a result of this measure.

According to officials with the City of New Orleans, Lafayette Consolidated Government, and City of Gretna, no material impact on revenues is expected as a result of posting notification of mobile speed camera locations.
