BUDGETARY PROCEDURES EG NO IMPACT See Note Page 1 of 1  
 Directs executive branch agencies receiving appropriations to prepare a report detailing the amount and impact of cuts to the agency's budget in FY 2016-2017

Proposed resolution directs every state agency that receives an appropriation in the General Appropriation Act or Ancillary Appropriation Act to prepare a report detailing the amount and impact of cuts to the agency's budget in FY 17; requires the commissioner of administration to develop the form and manner of submission of the reports, subject to approval of the House Committee on Appropriations; provides for specific information to be included in spreadsheets, a narrative report, and a report on employees and vacancies; and requires the information to be submitted to the House Committee on Appropriations no later than 9/30/17.
