

**SENATE FLOOR AMENDMENTS**

Amendments proposed by Senator Mills to Engrossed House Bill No. 26 by Representative Barras

1 AMENDMENT NO. 1

2 On page 1, line 3, after "Parish;" insert "to authorize the transfer of certain state property  
3 in Orleans Parish;"

4 AMENDMENT NO. 2

5 On page 1, line 3, change "description" to "descriptions"

6 AMENDMENT NO. 3

7 On page 1, after line 21, insert:

8 "Section 3. The commissioner of administration, notwithstanding any other  
9 provision of law to the contrary, is hereby authorized and empowered to convey,  
10 transfer, assign, lease or deliver the interest the state has to all or any portion of the  
11 following described parcel of property to the state of Louisiana from the Health  
12 Education Authority of Louisiana, a body corporate and public, constituting an  
13 instrumentality of the state of Louisiana:

14 The parking garage located at 300 LaSalle Street, New Orleans,  
15 Louisiana which parking garage is bounded by LaSalle Street, Gravier Street,  
16 Perdido Street, and Duncan Plaza, in the Parish of Orleans, Louisiana, and  
17 all of the equipment, vehicles, supplies, books, records, documents, papers,  
18 monies, actions, or any other item of property, and the improvements  
19 thereon, both movable and immovable, heretofore owned, held, used,  
20 operated, or maintained by the Health Education Authority of Louisiana.

21 Section 4. The commissioner of administration is hereby authorized to enter  
22 into such documents, contracts, agreements, covenants, conditions, stipulations, or  
23 other instruments and to execute such documents as necessary to properly effectuate  
24 any conveyance, transfer, assignment, lease, or delivery of title, to the property  
25 described in Section 3 of this Act. The commissioner of administration is hereby  
26 granted the right, power, and authority to do, perform, and exercise for and on  
27 behalf of the Health Education Authority of Louisiana all of the executive and  
28 administrative functions provided for by the constitution or laws with respect to the  
29 Health Education Authority of Louisiana with respect to the property described in  
30 Section 3 of this Act, including the right to do, perform, and exercise for and on  
31 behalf of the authority all acts and things required to be done and performed in  
32 connections with the authorization and issuance of revenue bonds by the authority,  
33 and the powers, duties, functions, and responsibilities shall be transferred to the  
34 commissioner of administration as provided in Part IV of Chapter 22 of Title 36 of  
35 the Louisiana Revised Statutes of 1950, as amended, which provisions shall be  
36 applicable to the authority and to the property described in Section 3 of this Act in  
37 order to effectuate the purposes of this Act.

38 Section 5. The provisions of Sections 3 through 5 of this Act shall supersede  
39 any other laws in conflict. The provisions of Sections 3 through 5 of this Act shall  
40 be liberally construed to effectuate these purposes."

41 AMENDMENT NO. 4

42 On page 2, line 1, change "Section 3." to "Section 6."
