Amendments proposed by Senator LaFleur to Engrossed House Bill No. 625 by Representative Henry

1 AMENDMENT NO. 1

2 In Senate Committee Amendment No. 34, proposed by the Senate Committee on Finance
3 and adopted by the Senate on June 1, 2017, on page 5, between lines 15 and 16, insert the
4 following:

5 "Provided, however, that the appropriation contained in Act No. 17 of the 2016 Regular
6 Session out of the Louisiana Legislature in the amount of \$17,000,000 for the thirteenth
7 managed care payment in Fiscal Year 2016-2017 when the Department of Revenue prevails
8 in the suit, appeal, or petition associated with the legislative instrument which originated as
9 House Concurrent Resolution No.8 of the 2015 Regular Session of the Legislature and
10 transfer the amount paid in protest and held in escrow in accordance with R.S. 47:1576 to
11 the State General Fund, and in the event the monies are recognized by the Revenue
12 Estimating Conference to be utilized to fund the thirteenth managed care payment, is null,
13 void, and of no effect, and the state treasurer shall not honor warrants thereon."

14 AMENDMENT NO. 2

15 In Senate Committee Amendment No. 39, proposed by the Senate Committee on Finance
16 and adopted by the Senate on June 1, 2017, on page 11, between lines 21 and 22, insert the
17 following:

18 "Section 4A. Notwithstanding any provisions of law to the contrary, any
19 appropriation contained in Schedule 20-901 Sales Tax Dedications or Schedule 20-945 State
20 Aid to Local Governmental Entities, in Act No. 17 of the 2016 Regular Session of the
21 Legislature which appropriation has a valid Cooperative Endeavor Agreement on June 30,
22 2017, shall be deemed a bona fide obligation through December 31, 2017 and all other
23 provisions of the Cooperative Endeavor Agreements, including but not limited to, the
24 reporting requirements, shall be performed as agreed.

25 Section 4B. Notwithstanding any provision of law to the contrary, any appropriation
26 contained in Other Requirements, Schedule 20-901 Sales Tax Dedications in Act 14 of the
27 2013 Regular Session of the Legislature for the Town of Delhi for the Cave Theater in the
28 amount of \$20,000 shall be deemed a bona fide obligation through June 30, 2018 and all
29 provisions of the Cooperative Endeavor Agreement executed between the Town of Delhi and
30 the Department of the Treasury, including but not limited to the requirements shall be
31 performed as agreed.

32 Section 4C. Notwithstanding any provision of law to the contrary, any appropriation
33 contained in Other Requirements, Schedule 20-901 Sales Tax Dedications in Act 54 of the
34 2013 Regular Session of the Legislature for the Town of Arnaudville in the amount of
35 \$20,000 shall be deemed a bona fide obligation through June 30, 2018 and all provisions of
36 the Cooperative Endeavor Agreement executed between the Town of Arnaudville and the
37 Department of the Treasury, including but not limited to the requirements shall be performed
38 as agreed."

40 In Senate Committee Amendment No. 39, proposed by the Senate Committee on Finance
41 and adopted by the Senate on June 1, 2017, on page 11, line 22, change "Section 4." to
42 "Section 5."
