STATE AGENCIES EN NO IMPACT See Note Re-creates the Department of the Treasury and its agencies. (6/30/17)

<u>Present law</u> provides that the Department of the Treasury and all statutory entities made a part of that department by law shall terminate its operations on July 1, 2018, and that all legislative authority for such entities shall cease as of July 1, 2019, unless the legislature enacts a bill authorizing the re-creation of the department and its statutory entities prior thereto.

<u>Proposed law</u> provides for the general re-creation of the Department of the Treasury and its statutory entities effective June 30, 2017, in accordance with the sunset law; supercedes the provisions of the sunset law that sets out the procedures for review and re-creation and that requires a separate bill to re-create each statutory entity within the department, along with additional provisions; makes July 1, 2023, the new termination date and termination would begin on July 1, 2022, unless the department is again re-created; and is effective June 30, 2017.
