2 To commend the Cedar Creek Cougars girls' softball team upon winning the Division IV
3 state championship; and recognize the team for their extraordinary achievements
4 during the 2017 softball season.

5 WHEREAS, the Cougar girls' softball team performed at the highest level of
6 excellence throughout the 2017 season, amassing a record of twenty-four wins and eleven
7 losses and finishing with five wins and zero losses in district play; and

8 WHEREAS, in 2017 the Cedar Creek Cougars girls' softball team made their third
9 trip in just four seasons to the All State Sugar Bowl Louisiana High School Association
10 softball championship; and

11 WHEREAS, the Cedar Creek Cougars took on the Vermilion Catholic Eagles in the
12 Division IV championship game at Frascch Park in Sulphur, Louisiana; and

13 WHEREAS, the Lady Cougars had outstanding performances in the state
14 championship game from several players, but most notably from senior pitcher, Mary Terral
15 who struck out nine batters while adding a double and two runs batted in on offense and
16 sophomore Anna Larr Roberson who hit a home run and added a single on offense; and

17 WHEREAS, Emily Ashcraft, Katelin Cooper, Alli Freeman, Mary Julia Klug, Lauren
18 Menzina, Kate Pardue, and Hallie Rambin all had singles on offense in the victory over the
19 Vermilion Catholic Eagles; and

1 WHEREAS, Cedar Creek fought off a late Vermilion Catholic rally and took a five
2 to three lead to capture their second Division IV state softball championship in four seasons
3 in a hard fought state championship game; and

4 WHEREAS, the accomplishments of this team could not have been achieved without
5 the unwavering dedication and guidance of head coach, Julie Riser; assistant coaches,
6 support staff, and fans; and

7 WHEREAS, the softball team's outstanding season upholds the winning tradition of
8 Cedar Creek High School, and all alumni and fans recognize the immense pride and
9 distinguished honor that the team brings to its school, community, and state.

10 THEREFORE, BE IT RESOLVED that the House of Representatives of the
11 Legislature of Louisiana does hereby commend and congratulate the players and coaches of
