3 "(1) The commissioner of administration, subject to legislative appropriation, shall
 4 take all necessary steps for the full implementation of the LaGov statewide enterprise
 5 resource planning financial system maintained by the office of technology services
 6 in the division of administration throughout the executive branch of state
 7 government, by not later than October 1, 2021.

25 On page 4, line 2, after "state" delete the remainder of the line and insert "payments issued
 26 to"

2 On page 4, line 9, after "charged to" delete the remainder of the line and insert the following:

3 "credit, debit, or other purchase cards and related fees to the extent available from
4 the card issuer."

7 minimum foundation program transfers."
