19 20 21	B.(1) Notwithstanding any other provisions of law to the contrary, the sales and use tax levied by the state of Louisiana and its political subdivisions shall not apply to the first two thousand five hundred dollars of the sales price or cost price
22 23 24	of any consumer purchases of <u>tangible personal property</u> , including firearms, ammunition, and hunting supplies, that occur each calendar year on the first consecutive Friday through Sunday of <u>September August</u> .
25	(2) (a) For purposes of this Section, "consumer purchases" shall mean
26	purchases by individuals of firearms, ammunition, and hunting supplies not for
27 28	business purposes. Consumer purchases shall not include the purchase of animals for the use of hunting.

29	(3) (b) For the purposes of this Section, "hunting supplies" shall mean
30	purchases of any tangible personal property for the use of hunting, including but not
31	limited to archery, off-road vehicles, and vessels such as ATVs, airboats, and
32 33	pirogues, accessories, animal feed, apparel, shoes, bags, float tubes, binoculars, tools,
34	firearm and archery cases, firearm and archery accessories, range finders, knives, decoys, treestands, blinds, chairs, optics, hearing protection and enhancements.

36	(4) (c) For purposes of this Section, "firearms" shall mean a shotgun, rifle
37	pistol, revolver, or other handgun.

1	(3) Except as otherwise provided in Paragraph (2) of this Subsection, for
2	purposes of this Section,"consumer purchases" shall mean purchases of items of
3	tangible personal property other than vehicles subject to license and title. Consumer
4	purchases shall not include the purchase of meals furnished for consumption on the
5	premises where purchased, including to-go orders."
