**HOUSE COMMITTEE AMENDMENTS**

2018 First Extraordinary Session

Amendments proposed by House Committee on Ways and Means to Original House Bill No. 23 by Representative Dwight

AMENDMENT NO. 1

On page 1, line 2, after "To" delete the remainder of the line, delete lines 3 through 6 in their entirety, and at the beginning of line 7, delete "47:302(BB), 321(P), 321.1(I), and 331(V)" and insert the following:

"amend and reenact R.S. 47:321.1(A) through (C) and (E) and to enact R.S. 47:302(BB) and (CC), 321(P) and (Q), 321.1(I) and (J), and 331(V) and (W)"

AMENDMENT NO. 2

On page 1, line 13, after "Section 1." delete the remainder of the line, delete lines 14 through 18 in their entirety, and insert the following:

"R.S. 47:321.1(A) through (C) and (E) are hereby amended and reenacted and R.S. 47:302(BB) and (CC), 321(P) and (Q), 321.1(I) and (J), and 331(V) and (W) are hereby enacted to read as follows:"

AMENDMENT NO. 3

Delete page 2 in its entirety, and on page 3, delete lines 1 through 17 in their entirety

AMENDMENT NO. 4

On page 3, at the beginning of line 20, insert "through and including June 30, 2020,"

AMENDMENT NO. 5

On page 11, between lines 2 and 3, insert the following:

"CC. The provisions of Subsection BB shall supercede and control to the extent of conflict with any other provision of law beginning June 30, 2018 through June 30, 2020."

AMENDMENT NO. 6

On page 11, delete lines 6 through 28 in their entirety, and on page 12, delete lines 1 through 17 in their entirety

AMENDMENT NO. 7

On page 12, line 19, after "2018," and before "there" insert "through and including June 30, 2020,"

AMENDMENT NO. 8

On page 20, between lines 8 and 9, insert the following:

"Q. The provisions of Subsection P shall supercede and control to the extent of conflict with any other provision of law beginning June 30, 2018 through June 30, 2020."

1 AMENDMENT NO. 9

2 On page 21, delete lines 14 through 29 in their entirety, and on page 22, delete lines 1  
3 through 6 in their entirety and insert the following:

4 "E. The provisions of this Section shall be inapplicable, inoperative, and of  
5 no effect after June 30, ~~2018~~. 2020."

7 On page 22, line 9, after "2018," and before "there" insert "through and including June 30,  
8 2020,"

9 AMENDMENT NO. 11

10 On page 29, between lines 28 and 29, insert the following:

11 "J. The provisions of Subsection I shall supercede and control to the extent  
12 of conflict with any other provision of law beginning June 30, 2018 through June 30,  
13 2020."

14 AMENDMENT NO. 12

15 On page 30, delete lines 3 through 27 in their entirety

16 AMENDMENT NO. 13

17 On page 30, line 29, after "2018," and before "there" insert "through and including June 30,  
18 2020,"

19 AMENDMENT NO. 14

20 On page 38, between lines 18 and 19, insert the following:

21 "W. The provisions of Subsection V shall supercede and control to the extent  
22 of conflict with any other provision of law beginning June 30, 2018 through June 30,  
23 2020."

24 AMENDMENT NO. 15

25 On page 38, line 19, after "321(M)," delete "321.1(E),"
