Section 1. R.S. 33:385.1(A) is hereby amended and reenacted to read as follows:

§385.1. Qualifications of elected chief of police

A. Except as otherwise provided in this Section, an elected chief of police of a municipality shall be an elector of the municipality. At the time of qualification as a candidate for the office of chief of police, he shall have been domiciled for at least the immediately preceding year in the municipality except that a person who resides outside of the corporate limits of the village of Maurice may be elected chief of police. Additionally, a person who resides outside of the corporate limits of the town of Gueydan, but within the territorial limits of Ward Three Fight of Vermilion Parish, may be elected chief of police of the town. The provisions of this Section shall not apply to the village of Napoleonville.

\* \* \*

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

SB 83 Original 2018 Regular Session

Present law requires that the elected chief of police of a municipality be an elector of the municipality and that at the time of qualification as a candidate for the office of chief of police, the candidate has been domiciled for at least the immediately preceding year in the municipality.

Present law does not apply to the village of Napoleonville.

<u>Present law</u> provides for exceptions authorizing a person residing outside the corporate limits of the village of Maurice to be elected chief of police of Maurice and by authorizing a person residing outside the corporate limits of the town of Gueydan, but within Ward 3 of Vermilion Parish, to be elected chief of police of the town.

Proposed law retains present law but changes the jurisdiction from which a person residing outside the corporate limits of the town of Gueydan, from Ward 3 to Ward 8 of Vermilion Parish, to be elected chief of police of the town.

Effective upon signature of the governor or lapse of time for gubernatorial action.
