HOUSE BILL NO. 325

DAIRY INDUSTRY: Establishes a permit fee for milk, dairy farms, and milk processing plants

1 AN ACT

2 To enact R.S. 40:31.39, relative to permit fees for milk and dairy farms and plants; to
3 provide for a permit fee for dairy farms; to provide for a permit fee for dairy plants;
4 to provide for a permit fee for single service milk and milk product container or
5 closure manufacturing plants; to set fee amounts; to provide for definitions; to
6 provide for an effective date; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 40:31.39 is hereby enacted to read as follows:

9 §31.39. Dairy farms and plants; milk plants; permit fees; definitions

10 A.(1) The department shall charge an annual fee in the amount of ninety
11 dollars per permit issued to a dairy farm.

12 (2) As used in this Subsection, the term "dairy farm" means any place or
13 premises where one or more cows, goats, sheep, water buffaloes, or other hooved
14 mammals are kept for milking and from which a part or all of the milk produced is
15 provided, sold, or offered for sale to a dairy plant, transfer station, or receiving
16 station possessing a permit from the Louisiana Department of Health.

17 B.(1) The department shall charge an annual fee in the amount of three
18 hundred dollars per permit issued to a dairy plant.

19 (2) As used in this Subsection, the term "dairy plant" means any place,
20 premises, or establishment where milk, milk products including frozen desserts,

1 frozen dessert mixes, filled milk or filled milk products, anomalous milk, anomalous
 2 milk products or anomalous dairy products, and dairy products are collected,
 3 handled, processed, stored, pasteurized, ultra-pasteurized, aseptically processed,
 4 churned, frozen, dried, blended, concentrated, condensed, packaged, or prepared for
 5 distribution and where milk tank trucks are cleaned and sanitized when received. The
 6 term also includes out-of-state facilities and establishments whose products are sold
 7 or distributed within the state of Louisiana.

8 C.(1) The department shall charge an annual fee in the amount of three
 9 hundred dollars per permit issued to a single service milk and milk product container
 10 or closure manufacturing plant.

11 (2) As used in this Subsection, the term "single service milk and milk
 12 product container or closure manufacturing plant" means fabricators, converters,
 13 printers, closure manufacturers, plastic laminators, sheet formers, blow molders,
 14 vacuum formers, plastic extruders, injection molders, preformers, manufacturers of
 15 valves, valve parts, tubes, dispensing devices, and sample containers for use with
 16 milk or milk products. The term also includes out-of-state facilities and
 17 establishments whose products are sold or distributed within the state of Louisiana.
