5	At the expiration of the delay periods as provided in R.S. 23:1629 through		
6	1634, or at the expiration of such additional time as may be necessary for the		
7	administrator to consider any application for waiver of overpayment as provided in		
8	R.S. 23:1713(B), the administrator shall proceed to assess an overpayment that he		
9	determines to be due under pursuant to this Chapter. This assessment shall be		
10	evidenced by a writing in any form suitable to the administrator which states the
