MOTOR VEHICLES. Reduces the fines for failure to maintain compulsory motor vehicle liability security. (8/1/18)

AN ACT

2	To amend and reenact R.S. 32:863.1(I), relative to evidence of compulsory motor vehicle
3	liability security; to reduce the amount of the fines for failure to maintain motor
4	vehicle liability security; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 32:863.1(I) is hereby amended and reenacted to read as follows:
7	§863.1. Evidence of compulsory motor vehicle liability security contained in
8	vehicle; enforcement; penalty; fees
9	* * *
10	I.(1) Every owner or lessee of a self-propelled motor vehicle registered in
11	another state which is involved in a traffic accident or collision in Louisiana shall
12	provide one of the documents comparable to those listed in Subsection A evidencing
13	that the motor vehicle is covered by a valid policy of automobile insurance. If the
14	operator of the motor vehicle is unable to show such proof, a notice of
15	noncompliance shall be issued by the office of motor vehicles.
16	(2) If the operator of the motor vehicle is issued a notice of noncompliance,
17	the owner of the vehicle shall have thirty working days from the date that the notice

of noncompliance was issued to present to the office of motor vehicles proof that
insurance coverage was in effect at the time of the issuance of the notice of
noncompliance or proof that insurance coverage was not required by the state in
which the vehicle was registered.

(3) If the owner fails to provide the proof required in Paragraph (2) of this

(3) If the owner fails to provide the proof required in Paragraph (2) of this Subsection, there shall be a fine of one hundred fifty dollars for a first offense, a fine of two one hundred fifty dollars for a second offense, and a fine of five three hundred dollars for any subsequent offense.

<u>Present law</u> provides for the following penalties for failure to maintain evidence of compulsory motor vehicle liability insurance:

- (1) A fine of \$100.00 for a first offense.
- (2) A fine of \$250.00 for a second offense.
- (3) A fine of \$500.00 for a third and subsequent offense.

<u>Proposed law</u> changes the penalties for failure to maintain evidence of compulsory motor vehicle liability insurance to the following:

- (1) A fine of \$50 for a first offense.
- (2) A fine of \$150 for a second offense.
- (3) A fine of \$300 for a third and subsequent offense.

Effective August 1, 2018.
