WHEREAS, Mr. Lee worked more than thirty-five years with the Lafayette Parish School Board serving as a teacher of industrial arts, math, and carpentry; and

WHEREAS, in addition to teaching, he excelled in his chosen career path and became an assistant principal and, subsequently, principal at J. W. Faulk Elementary and assistant principal at Acadian Middle School; and

WHEREAS, he later became the principal of L. Leo Judice Elementary School, and in 2001, Mr. Lee retired from that position with more than thirty-five years of dedicated

WHEREAS, after retirement, Mr. Lee spent an additional six years as a substitute principal at various schools in Lafayette Parish; and

WHEREAS, Mr. Lee was a motivated and active member in his community and his church, Immaculate Heart of Mary, where he served as an usher, Eucharistic Minister for the sick and homebound, and member of the Knights of Peter Claver; and

WHEREAS, one of his proudest accomplishments was coaching his daughters throughout their teenage years in basketball and softball, which resulted in both of them being awarded athletic scholarships; and

WHEREAS, as a result of his love of sports, Mr. Lee served the community by becoming an official with the Louisiana High School Athletic Association in Lafayette Parish for basketball and football and was privileged to have been selected as an official for several state championship games; and

WHEREAS, in his spare time, he was an outdoorsman who enjoyed fishing, hunting, and golf; and

WHEREAS, he also specialized in cabinet making and, most importantly, spending time with his family and friends as the life of the party; and

WHEREAS, John Melvin "Rock" Lee is survived by his two daughters, Nika Echols and Courtney Williams; four grandchildren, Anthony Eugene Echols, Aaron John Echols, Cordell "CJ" La'Michael Williams Jr., and Cynthia "Cindy" Lauren Williams; three siblings, Samuel Lee, Alice Hayward, and Wilton Lee; and numerous nieces and nephews; and

WHEREAS, he was preceded in death by his parents, Wilton and Louversa Lee, as well as his adoring wife of thirty-one years, Cynthia; and

WHEREAS, with the death of John Melvin "Rock" Lee, Louisiana has lost one of its finest sons, a quintessential southern gentleman who loved his community and whose accomplishments have left an indelible mark upon his community, state, and nation; and

WHEREAS, the death of John Melvin "Rock" Lee has left a substantial void in the Lafayette community and a sense of loss in the citizens whose lives he touched, and his memory shall live forever in the minds and hearts of all those who knew and loved this remarkable gentleman.
