EXPENDITURE EXPLANATION

This measure is anticipated to have a nominal impact on expenditures of the Louisiana Workforce Commission (LWC). The bill provides for the renaming of the Louisiana Workforce Commission to the Louisiana Department of Labor. LWC anticipates making name changes associated with car decals, stationery, business cards, employee I.D. badges, web pages, and any other incidental materials over the normal course of business. Therefore, any cost to convert to the new name will be minimal and absorbed through LWC's existing budget. Historically, these costs have been covered through federal funds and statutory dedications (Incumbent Worker Training Fund, Office of Workers' Compensation Fund, and Workers' Compensation Second Injury Fund).

REVENUE EXPLANATION
