**Abstract:** Provides relative to the board of commissioners of Vermilion Parish Hospital Service District No. 2, increases the maximum per diem authorized to be paid to members for attending board meetings from \$50 to \$125.

<u>Present law</u> authorizes the governing authority of Vermilion Parish to permit a per diem to each member of the board of commissioners of Vermilion Parish Hospital Service District No. 2 for attendance at meetings of the commission, not to exceed 24 regular meetings per year and 12 special meetings per year, payable out of the funds of the district. <u>Proposed law</u> retains present law.

<u>Present law</u> provides that the maximum per diem is \$50. <u>Proposed law</u> increases the maximum per diem to \$125.
