**Abstract:** Provides for retroactive effect of the registration of a foreign partnership and filing of articles of partnership or foreign equivalent to the date of the acquisition of the immovable property.

<u>Present law</u> provides that a foreign partnership must be registered with the secretary of state in order to own property in this state or have the limited liability of its limited partners recognized.

<u>Proposed law</u> requires the filing of written articles of partnership or its foreign equivalent and authorizes the registration of the foreign partnership after the acquisition of property and provides for retroactive effect of the registration and filing to the date of the acquisition of the property.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by House Committee on Civil Law and Procedure to the original bill:

1. Add a requirement to file the foreign equivalent of written articles of partnership.
