AN ACT

CRIME/FELONIES: Amends penalties relative to the crime of hazing

2	To amend and reenact R.S. 17:1801 and to enact R.S. 14:40.8, relative to acts of hazing; to
3	create the crime of hazing; to provide exceptions, definitions, and criminal penalties
4	relative to the crime of hazing; to provide relative to consequences imposed by the
5	educational institution for certain acts of hazing; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 14:40.8 is hereby enacted to read as follows:
8	§40.8. Hazing
9	A.(1) Except as provided by Subsection D of this Section, no person shall
10	engage in or participate in the hazing of another person.
11	(2)(a) Except as provided by Subparagraph (b) of this Paragraph, any person
12	who engaged in or participated in the hazing shall be either fined up to one thousand
13	dollars, imprisoned for up to six months, or both.
14	(b) If the hazing results in the serious bodily injury or death of the victim,
15	or results in the victim having a blood alcohol concentration of at least .25 percent
16	by weight based on grams of alcohol per one hundred cubic centimeters of blood,
17	any person who engaged in or participated in the hazing shall be fined up to ten
18	thousand dollars and imprisoned, with or without hard labor, for up to five years.
19	B. If any person serving as a representative or officer of an organization,
20	including any representative, director, trustee, or officer of any national or parent

1	organization of which any of the underlying entities provided for in Paragraph (C)(3)
2	of this Section is a sanctioned or recognized member at the time of the hazing, knew
3	and failed to report to law enforcement that one or more of the organization's
4	members were engaging in or participating in the hazing of another person, the
5	organization may be subject to the following:
6	(1) Payment of a fine of up to ten thousand dollars.
7	(2) Forfeiture of any public funds received by the organization.
8	(3) Forfeiture of all rights and privileges of being an organization that is
9	organized and operating at the educational institution for a specific period of time as
10	determined by the court. If the hazing results in the serious bodily injury or death
11	of the victim, or results in the victim having a blood alcohol concentration of at least
12	.25 percent by weight based on grams of alcohol per one hundred cubic centimeters
13	of blood, the period of time shall be for not less than four years.
14	C. For purposes of this Section:
15	(1) "Educational institution" means any elementary or secondary school or
16	any postsecondary education institution in this state.
17	(2)(a) "Hazing" is any intentional, knowing, or reckless act by a person
18	acting alone or acting with others that is directed against another when both of the
19	following apply:
20	(i) The person knew or should have known that the act endangers the
21	physical health or safety of the other person or causes severe emotional distress.
22	(ii) The act was associated with pledging, being initiated into, affiliating
23	with, participating in, holding office in, or maintaining membership in any
24	organization.
25	(b) "Hazing" includes but is not limited to any of the following acts
26	associated with pledging, being initiated into, affiliating with, participating in,
27	holding office in, or maintaining membership in any organization:
28	(i) Physical brutality, such as whipping, beating, paddling, striking, branding,
29	electronic shocking, placing of a harmful substance on the body, or similar activity.

1	(ii) Physical activity, such as sleep deprivation, exposure to the elements,
2	confinement in a small space, or calisthenics, that subjects the other person to an
3	unreasonable risk of harm or that adversely affects the physical health or safety of
4	the individual or causes severe emotional distress.
5	(iii) Activity involving consumption of food, liquid, or any other substance,
6	including but not limited to an alcoholic beverage or drug, that subjects the
7	individual to an unreasonable risk of harm or that adversely affects the physical
8	health or safety of the individual or causes severe emotional distress.
9	(iv) Activity that induces, causes, or requires an individual to perform a duty
10	or task that involves the commission of a crime or an act of hazing.
11	(c) A physical activity that is normal, customary, and necessary for a
12	person's training and participation in an athletic, physical education, military
13	training, or similar program sanctioned by the educational institution is not
14	considered "hazing" for purposes of this Section.
15	(3) "Organization" means a fraternity, sorority, association, corporation,
16	order, society, corps, cooperative, club, service group, social group, band, spirit
17	group, athletic team, or similar group whose members are primarily students at, or
18	former students of, an educational institution."Organization" includes the national
19	or parent organization of which any of the underlying entities provided for in this
20	Paragraph is a sanctioned or recognized member at the time of the hazing.
21	(4) "Pledging", also known as "recruitment" or "rushing" means any action
22	or activity related to becoming a member of an organization.
23	D.(1) This Section does not apply to an individual who is the subject of the
24	hazing, regardless of whether the individual voluntarily allowed himself to be hazed.
25	(2) It is not a defense to prosecution for a violation of this Section that the
26	individual against whom the hazing was directed consented to or acquiesced in the
27	<u>hazing.</u>
28	E.(1) The penalties provided in Subsection B of this Section may be imposed
29	in addition to any penalty that may be imposed for any other criminal offense arising

from the same incident or activity, and in addition to any penalty imposed by the organization or educational institution pursuant to its by-laws, rules, or policies regarding hazing.

(2) Nothing in this Section precludes any civil remedy provided by law.

Section 2. R.S. 17:1801 is hereby amended and reenacted to read as follows:

§1801. Hazing prohibited; penalties

<u>A.</u> Hazing in any form, or the use of any method of initiation into fraternal organizations in any educational institution supported wholly or in part by public funds, which is likely to cause bodily danger or physical punishment to any student or other person attending any such institution is prohibited.

<u>B.</u> Whoever violates the provisions of this Section shall be fined not less than ten dollars nor more than one hundred dollars, or imprisoned for not less than ten days nor more than thirty days, or both, and in addition, shall be expelled suspended or dismissed from the educational institution and not permitted to return for at least during the current session or term in which the violation occurs. <u>In addition</u>, the person violating the provisions of this Section may also be subject to the provisions of R.S. 14:40.8 which provides penalties for certain hazing activity. Section 3. This Act shall be referred to as "The Max Gruver Act".

**Abstract:** Creates the crime of hazing at certain educational institutions and provides for exceptions, definitions, and penalties relative to the offense, and further provides relative to consequences imposed by the educational institution for acts of hazing.

<u>Present law</u> provides that hazing in any form, or the use of any method of initiation into fraternal organizations in any educational institution supported wholly or in part by public funds, which is likely to cause bodily danger or physical punishment to any student or other person attending any such institution is prohibited. Further provides that whoever violates these provisions of <u>present law</u> shall be fined not less than \$10 nor more than \$100, or imprisoned for not less than 10 days nor more than 30 days, or both, and in addition, shall be expelled from the educational institution and not permitted to return during the current session or term in which the violation occurs.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> amends <u>present law</u> to apply to any organization in an educational institution, and to remove the fine and term of imprisonment as consequences for engaging in this activity and provide that the student may be dismissed or suspended from the educational institution for at least the current session or term in which the violation occurs. Further provides that persons who engage in such activity may be subject to the provisions of proposed law which provides penalties for persons who engage in hazing activity.

<u>Proposed law</u> creates the crime of hazing which prohibits any person from engaging in or participating in the hazing of another person, regardless of whether the person voluntarily allowed himself to be hazed or consented to the hazing. Further provides for the following penalties:

- (1) A fine of up to \$1,000, imprisonment for up to six months, or both.
- (2) If the hazing results in the serious bodily injury or death of the victim, or results in the victim having a blood alcohol concentration of at least .25 percent by weight based on grams of alcohol per one hundred cubic centimeters of blood, the person who engaged in or participated in the hazing shall be fined up to \$10,000, and imprisoned, with or without hard labor, for up to five years.

<u>Proposed law</u> also provides that if any person serving as a representative or officer of an organization, including any representative, director, trustee, or officer of any national or parent organization of which any of the underlying organization is a sanctioned or recognized member at the time of the hazing, knew and failed to report to law enforcement that one or more of the organization's members were engaging in or participating in the hazing of another person, the organization may be subject to the following:

- (1) A fine of up to \$10,000.
- (2) Forfeiture of any public funds received by the organization.
- (3) Forfeiture of all rights and privileges of being an organization that is organized and operating at the educational institution for a specific period of time as determined by the court. If the hazing results in the serious bodily injury or death of the victim, or results in the victim having a blood alcohol concentration of at least .25 percent by weight based on grams of alcohol per one hundred cubic centimeters of blood, the period of time shall be for not less than four years.

<u>Proposed law</u> defines "hazing" as any intentional, knowing, or reckless act by a person acting alone or acting with others that is directed against another when both of the following apply:

- (1) The person knew or should have known that the act endangers the physical health or safety of the other person or causes severe emotional distress.
- (2) The act was associated with pledging, being initiated into, affiliating with, participating in, holding office in, or maintaining membership in any organization.

<u>Proposed law</u> further provides that "hazing" includes but is not limited to any of the following that is associated with pledging, being initiated into, affiliating with, participating in, holding office in, or maintaining membership in any organization:

- (1) Physical brutality, such as whipping, beating, striking, branding, electronic shocking, placing of a harmful substance on the body, or similar activity.
- (2) Physical activity, such as sleep deprivation, exposure to the elements, confinement in a small space, or calisthenics, that subjects the other person to an unreasonable

risk of harm or that adversely affects the physical health or safety of the individual or causes severe emotional distress.

- (3) Activity involving consumption of food, liquid, or any other substance, including but not limited to an alcoholic beverage or drug, that subjects the individual to an unreasonable risk of harm or that adversely affects the physical health or safety of the individual or causes severe emotional distress.
- (4) Activity that induces, causes, or requires an individual to perform a duty or task that involves the commission of a crime or an act of hazing.

<u>Proposed law</u> provides exceptions for normal physical activity associated with athletics, physical education, military training, or similar programs.

<u>Proposed law</u> also defines "organization" as a fraternity, sorority, association, corporation, order, society, corps, cooperative, club, service group, social group, band, spirit group, athletic team, or similar group whose members are primarily students at, or former students of, an elementary or secondary school or a postsecondary education institution in this state. Further includes the national or parent organization of which any of these underlying entities is a sanctioned or recognized member at the time of the hazing.

Finally, <u>proposed law</u> provides that the penalties provided by <u>proposed law</u> do not preclude any civil remedies provided by <u>present law</u> and may be imposed in addition to any penalty that may be imposed for any other <u>present law</u> criminal offense arising from the same incident or activity, and in addition to any penalty imposed by the organization or educational institution pursuant to its by-laws, rules, or policies regarding hazing.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Administration of</u> Criminal Justice to the original bill:

- 1. Provide that the penalty provision imposing upon a person who engaged in or participated in the hazing a fine of up to \$10,000, and imprisonment for up to five years, shall also apply if the hazing resulted in the victim having a blood alcohol concentration of at least .25 percent by weight based on grams of alcohol per one hundred cubic centimeters of blood.
- 2. Specify that the penalties imposed upon the organization applies if any person serving as a representative or officer of an organization, including any representative, director, trustee, or officer of any national or parent organization of which any underlying organization is a sanctioned or recognized member, knew and failed to report the hazing to law enforcement.
- 3. Decreases the potential fine imposed upon the organization from \$100,000 to \$10,000.
- 4. With regard to the court's authority to order that the organization forfeit all rights and privileges of being an organization that is organized and operating at the educational institution, provide that the court shall specify the duration and requires the duration to be at least four years if the hazing results in death, serious bodily injury, or the victim having a blood alcohol concentration of at least .25 percent by weight based on grams of alcohol per one hundred cubic centimeters of blood.

5. With regard to the exception for physical activities associated with athletic, physical education, military training, or similar programs, specify that the activity must be normal, customary, and necessary for the person's training and participation in the program.

- 6. Amend the definition of "organization" to include the educational institution and the national or parent organization of which any of the underlying entities is a sanctioned or recognized member at the time of the hazing.
- 7. Provide that the duration for which any student that is suspended or dismissed from the educational institution for violations of the <u>present law</u> provisions which prohibit hazing shall be for at least the current session or term in which the hazing occurs.
- 8. Provide that the Act shall be referred to as "The Max Gruver Act".
