35	exemption; provided, that if less than three businesses receive a particular tax
36	exemption, the tax exemption budget may group such tax exemption with

38 39	(iii) The information shall be displayed in a manner that identifies: (aa) The industry group by North American Industry Classification
39 40	System sector.

3	(dd) The total value to each industry group for each exemption.
4	(ee) The total tax value by each industry group by individual tax of the

6	(e) The items contained in Subparagraph (B)(1)(d) of this Section shall
7	be published to the extent that the information is available to the department,
8	on a schedule to be determined by the secretary of the department, beginning
9	with the incentive expenditures, and fully implemented by the date of
10	publication of the Fiscal Year 2019-2020 tax exemption budget on or before
11	March 1, 2020. The secretary shall ensure that the publication shall not include
12	confidential information.
