Present law provides for the election of school board members to four-year terms. Provides that such elections are held at the same time as congressional elections. Present law further provides for the Lafayette Parish School Board to begin having elections at the same time as gubernatorial elections beginning in 2019. Proposed law retains present law except to provide that school board members are elected at the same time as the gubernatorial election. Proposed law provides by way of transition that members elected in 2018 will serve five-year terms and those elected in 2020 will serve three-year terms, and beginning in 2023 all school board members will be elected to four-year terms at the gubernatorial election.
